Re: Notice for Subscription Fee for the FY-2026-27

Members are hereby informed that the annual IIISLA Membership Subscription Fee for the financial year 2026–27, along with 18% GST, will be payable from 11th May 2026.

All members are kindly requested to ensure that the payment is made on or before 25th May 2026 to maintain active membership status.

Those members, who don't pay their annual IIISLA Membership subscription fee on or before 25<sup>th</sup> May 2026, " As per article 4 of AOA of IIISLA, are liable to be removed from the membership of IIISLA, as per article 14(iii). However, such of the members removed from the membership of IIISLA are eligible for "readmission membership", after clearing their dues along with "readmission charges", at the discretion of the Council, as per 14 (iii) sub clause.

## **SPECIAL DISCOUNTS**

(i) The Institute in its endeavor to the national cause of empowering woman surveyors assures a 50% discount for woman Licentiate Members, in their payable FY 26-27 Subscription only.

(ii) The Institute also wants to recognize the senior fraternities, by assuring 25% discount for Surveyors over 65 Years, as of April 1<sup>st</sup> 2026, in their payable FY 26-27 Subscription only.

Any woman surveyors who qualify in both the above parameters shall be eligible only for the clause i) and shall not be eligible for both the discounts for the FY 26-27.

The re-admission charge for the FY 26-27 is Rs.2000 + GST, if not paid their dues before 25<sup>th</sup> May 2026. This readmission charges are applicable to all subscription payments of FY26-27, made after 01<sup>st</sup> June 2026, including any previous arrears, due to non - payment of subscription, and readmission charges of previous years accumulated, over a period of year / years in a member's demand.

The payments are to be made by way of Online (only) by member logging into their respective IIISLA Portal.
